NOTICE TO EXHIBITORS

- EXHIBITORS, OWNERS & AGENTS ASSUME ALL RESPONSIBILITY FOR DOGS AND EQUIPMENT ON THE SHOW SITE.
- Each exhibitor is responsible for keeping his grooming area and exercise pen clean and orderly. All waste and residue must be cleaned up and properly disposed, before leaving the site. OWNERS OF DOGS ARE RESPONSIBLE FOR ANY FECES LEFT BY THEIR ANIMALS, AND DISPOSING OF IT IN A SANITARY MANNER.
- ERRORS ON ENTRY BLANKS: Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fees will be refunded in the event of such errors or cancellation of entries after the published closing date. Changes, additions or corrections to entry forms must be received in writing or by telegram prior to close of entries. Those received by telephone are not acceptable. There will be no refund of duplicate entries. Returned checks do not constitute a valid entry fee.
- Entry fees shall not be refunded in the event that a dog is absent; disqualified; excused by the Veterinarian or Judge or barred from competition by action of the Show Committee or cancellation of a win by the American Kennel Club. No entry fee will be refunded if the show cannot open or be completed by reason of riots, civil disturbances, fire, an Act of God, public emergency, strikes or any other cause beyond the control of the club. Obedience Trial only . . . a bitch in season on the day of the show will be refunded 50% of entry fee with a veterinarian's certificate.
- JUDGES ARE NOT REQUIRED TO WAIT FOR DOGS. THEY WILL ADHERE AS CLOSELY AS POSSIBLE TO THE JUDGING SCHEDULE. The owner or handler of each dog is solely responsible for having it ready at ringside when its class is being judged. The show-giving club and the show secretary have no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.
