ENTRIES CLOSE ON October 3, 2025 at 5 PM after which time entries cannot be accepted, cancelled, altered, or substituted. Entries received prior to the opening date shall be treated as an invalid entry and shall be returned to the sender. A waitlist will be maintained.

DAY OF EVENT ENTRIES: Day of event entries will be accepted to a maximum of 40 total entries.

DOG ELIGIBLE TO ENTER

This trial is open to all dogs NINE (9) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number or approved Foundation Stock Service (FSS) breeds are eligible to participate. Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete.

Condition of the Dog. Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, they display no signs of physical discomfort and can safely complete the test. Dogs with bandages, sutures, or visible wounds are not eligible. Deaf dogs are allowed to enter so long as the handler is in control of the dog at all times, the dog can complete the requirements of the test, and the dog does not appear to be under undue stress in the opinion of the judge.

No entries will be accepted by phone or fax. Express mail entries must include the signature waiver allowing them to be left at the secretary's address. WAIT LIST INFORMATION

Lakeshore Pembroke Welsh Corgi Club is offering a wait list to fill openings created by withdrawn entries after the trial's closing date/time. All entries, including wait listed entries, must be received by the Trial Secretary prior to **5 PM October 3, 2025 unless other arrangements are made with the TRIAL SECRETARY**. No entries may be withdrawn with a refund after closing on October 3. If a withdrawn entry is replaced by a wait listed entry, a full refund will be issued for the withdrawn entry. Any wait listed entry that does not move off the wait list into the trial will receive a full refund.

SIGN-IN

There will be a secretary's table for check-ins and information.

ADDITIONAL SITE INFORMATION

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

NOTICE TO EXHIBITORS

SAFETY, BEHAVIOR and LIABILITY

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all searches safely. **It is expressly understood** that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The American Kennel Club, Lakeshore Pembroke Welsh Corgi Club and their agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The American Kennel Club and Lakeshore Pembroke Welsh Corgi Club reserve the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the American Kennel Club, Stone City Kennel Club or any official thereof.

Collars, Leashes, and Harnesses. Dogs must wear a collar. Dogs may wear a well fitting flat collars in the AKC Farm Dog test. They may not wear prong collars, e-collars, head collars, muzzles, or body harnesses. Leashes should be 4 ft. to 6 ft. long and should be made of fabric, leather, or biothane.

All dogs must be on leash at all times, and retractable leashes may not be used when on trial grounds. Dogs must enter and exit the test area with the leash attached to the collar, including when waiting on the test.

REFUNDS

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. Dogs pulled after closing because of injury or other medical condition are not eligible for a refund.

Notification in writing must be given to the trial secretary no later than one half hour prior to the start of the trial.

RINGSIDE

Judges are not required to wait for dogs, however, judges, the judge in the second trial will wait if the delay is due to timing in the first trial. The Owner of each dog is solely responsible for having it ready at the test area when it is to be judged. The Club has no responsibility to provide service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

EXHIBITOR CHECK-IN: Armband numbers will not be issued. Once the time and location for check-in is determined all exhibitors will be notified by email.

Claims will be arbitrated as set forth on the Official AKC Entry Form for this event.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations." Additionally, clubs should include any specific local or state health requirements; for example, proof of rabies vaccination.

DIRECTIONS TO SITE: The address of the site is [15787 Crowley Road](#), Durand, IL. The city of Durand is NE of Freeport, IL and NW of Rockford, IL.

: From I-90, take exit 3 for E. Rockton Rd, keeping left at the fork, follow signs to Rockton/Roscoe. Merge onto E Rockton Rd. In 2.3 miles, turn right onto Dorr Road. In one mile, turn left onto Prairie Hill Rd. Then in 1.6 miles, turn left onto S. Bluff Rd. and in .2 miles turn right onto Yale Bridge Rd. Stay on Yale Bridge for 13 miles and then turn right on to Crowley. 15787 will be on the right in .9 miles.
